Penalties on fees-in-arrears:

- (i) Invoices for annual registration fees - due by 31st March - are (initially) dispatched annually during the last week in January (by e-mail "snail" mail)
- (ii) Section 20 of Act 49/2000 makes provision for a 60-day period of grace after 31st March for remittance of registration fees, expiring on 31st May
- (iii) The penalty for late or non-payment of registration fees applies with effect from 1st June
- (iv) Current penalties are subject to the same annual percentage increases as all other SACQSP fees
